## KEY PROJECTS

### **Baseline GHG Inventory and Mandatory Disclosure Assessment | Abergeldie Complex Infrastructure**

*Technical Analysis, ESG Strategic Advisory, Reporting and Disclosure Readiness*

WolfPeak developed a comprehensive Scope 1, 2 and 3 greenhouse gas (GHG) inventory and emissions reduction strategy to align with the Australian Sustainability Reporting Standards (ASRS). The project established a baseline GHG emissions inventory in line with the GHG Protocol and National Greenhouse and Energy Reporting Scheme, modelling emissions reduction targets and undertaking a climate disclosure readiness review to ensure compliance with the ASRS. The outcomes provided Abergeldie with a clear emissions profile, reduction strategies and a structured approach to meeting mandatory climate disclosure obligations.

### **Sustainability Building Audit | Amazon**

*Sustainability Auditing, GHG Inventory*

WolfPeak conducted sustainability audits for two AWS buildings in Sydney, including a detailed carbon inventory and assessment of environmental performance. This data was analysed and used to develop carbon offset guidance documentation to support emissions reduction goals which aligned with company goals and values and highlighted areas that may lead to cost savings for the organisation.

### **Botany Rail Duplication – Sustainability Manager | John Holland**

*Sustainability Management, Technical Analysis*

WolfPeak provided sustainability management support to the Botany Rail Duplication Project, working as part of John Holland's delivery team to manage all sustainability aspects of the project. This included delivering the Project's IS Rating Design submission and preparing associated resource usage modelling. Key sustainability initiatives included rainwater harvesting and reuse and the adoption of biodiesel during construction. The project achieved enhanced resource efficiency and energy reductions, with ARTC commending WolfPeak's expertise and dedication.

### **Embodied Emissions Framework Review | Department of Planning, Housing and Infrastructure**

Fulton Hogan Eastern Region Construction engaged WolfPeak to review sustainability performance across multiple construction projects, focusing on delivering Infrastructure Sustainability (IS) Ratings administered by the Infrastructure Sustainability Council (ISC). This review identified key challenges and opportunities relating to the implementation of sustainable practices on their construction projects. Targeted recommendations and actions were provided to enhance project sustainability performance and delivery efficiency.

### **Malabar Biomethane Project | Jemena** *Sustainability Management, Technical Analysis*

WolfPeak successfully supported Jemena in delivering an As-Built IS Essentials Rating for the biomethane facility project working closely with the design and delivery team. This was the first biomethane facility certified under the IS Rating scheme.

### **Sydney Metro, Western Sydney Airport SSTOM Package | WeBuild** *Advisory, Sustainability Management*

WolfPeak worked with the delivery team for the Sydney Metro Western SSTOM Project to deliver the Project's IS Rating Design submission. The Project was required to achieve a 'Leading' IS Rating score of >80 for Design and As Built using version 1.2 of IS Council's rating tool. WolfPeak coordinated with design, procurement, and construction teams to ensure the consideration and implementation of sustainability initiatives, risk mitigation measures, and contract requirements.

### **RM Watson ESG Strategy | RM Watson** *Advisory, Technical Analysis*

WolfPeak led the development of RM Watson's first corporate ESG Strategy. This included conducting a materiality assessment with internal and external stakeholders to determine the most critical ESG issues for RM Watson. Following this, WolfPeak undertook data analysis of the material ESG issues to set a baseline for the company. WolfPeak facilitated a collaborative process with key RM Watson stakeholders to develop an ESG Strategy containing practical actions to manage the company's ESG issues, preparing RM Watson to meet client procurement ESG requirements and strengthen its market positioning.
